EEC (European Economic Community) Regulation 815/84

«De-institutionalization program» was the beginning in order to abolish the psychiatric closed care communities.

According to this Program, for the period 1984-1995:

-260 new structures were developed, such as Mental Health Centres, Psychiatric Departments in General Hospitals, Day Hospitals, Rehabilitation Laboratories, hostels, boarding schools and other services.

"PSYCHARGOS" Reform on Psychiatric Sector

"PSYCHARGOS" Psychiatric Reform Program is a National Plan in order to change the way mental health services are provided. The main purpose was to relocate the centre of attention from the provided internal immune-type treatment towards the open care centers in the community.

"PSYCHARGOS" Reform in the Psychiatric Sector

<u>Phase 1. (2000-2001)</u> – Continuing the process of deinstitutionalization of patients who are hospitalized in the major public psychiatric hospitals of Greece.

Phase 2. (2002 – 2009) — Organization of 467 new structures, including 34 Centres for mental health, 31 Psychiatric Departments in General Hospitals, 146 units for vocational rehabilitation, 227 living accommodation structures, boarding houses, supporting apartments.

<u>Phase 3. (2010-2020)</u> – Preparation of the National Action Plan "PsychArgos 3" in three pillars of action.

- 1. Planning of actions for the development of community structures.
- 2. Design actions to promote the mental health of the general population and the prevention of mental health.
- 3. Organization of the psychiatric care system, the research and training activities of the staff.

Law 2716/1999:

This law is the base of "PSYCHARGOS" Reform Program and according to its provisions:

- the incarceration in closed -care institutions is abolished and structures that provide open psychiatric care are created. More specifically sectors of mental health care are established as we saw before.
- -Members of Social co operatives gain the profits without losing the right to the welfare allowance.
- -Special centers of social re- integration and professional rehabilitation for adults, adolescents and children are created.

law 74/B 29/01/2007

It is about the legal framework that concerns the establishment and the function of Assisted Accommodation for people with mental disabilities.

-Law 4019/11 article 10

- -Social Co- Operatives are being established as agents of Social Economy.
- -People with Disabilities that participate in training programs or are being occupied in Social Co operatives and at the same time they obtain social welfare they can continue to receive all the provisions.

Law 4021/2011

It concerns adjustments of the low rate of the real estate fee for people with mental disability, Down syndrome, autism and cerebral palsy with a disability percentage of 67%.

Law 4025/2011:

The Disability Certifying Centers (D.C.C) are being established.

According to the provisions of the Law, those who are interested in obtaining welfare financial aids are obligatory examined by the D.C.C. In order to obtain a welfare allowance they should have a disability percentage of at least 67%.

Law 4430/16 (article 74)

It refers to Social Economy and Social solidarity.

There are also provisions that concern the occupation of people with disability of 50% and more: employers are given extra credit when they employ people from this vulnerable group.

As regard as the structures that issue the allowances about beneficiaries without insurance :

Law 2218/1994: Establishing Departments of Social Protection in the Prefectures having the responsibility of issuing welfare allowances, including severe disability of mentally ill.

Law 3482/10: Kallikratis reformation: Municipalities take up the responsibility of welfare allowances.

Law 57(issue B' 18/1/2018) For the first time a new digital pilot program starts in the municipalities for the residents of Prefecture of Attika. It concerns granting welfare allowances to disabled people and especially those who are interested in taking the financial aid for the first time.

Discount in Municipal Taxes

In the Municipality of Aghii Anargiri Kamatero the Municipal Board has decided to fully exempt from Municipal taxes disabled people with more than 67% of disability and family income up to 14.400 euros. Respectively when the incomes are higher there's a reduction of 50%.

Social Household Bill for the Electric power

For those who have a disability of 67% and more or they have under their protection a member with such a disability and their family income is less than the personal tax free limit, they have a reduction of 20% in their electricity household bill.


More provisions

- An Adult unit

- Open Psychosocial Care Department for adults
- Open Care Centre for adults with mental disorders who are followed up by Hospital.


